Interpretation of Protocol

The test scores and interpretive information found in this report are offered based on the following assumptions. First, it is assumed that the VAS-R was administered and scored according to the criteria set forth in chapter 2 of the VAS-E/VAS-R Professional Manual (Gerhardstein Nader, 2013). Second, it is assumed that individuals reading and interpreting this report are appropriately qualified and credentialed according to the guidelines set forth in chapter 2 of the Professional Manual (Gerhardstein Nader, 2013).

The VAS-R is a measure of receptive vocabulary or the auditory comprehension of word meaning. Receptive vocabulary on the VAS-R requires the recognition of a word's meaning and enough verbal or motor ability enough to choose a correct response. It is normed on individuals from the ages of 2 years, 6 months to 95 years old. Performance is expressed as standard score that is scaled to a mean of 100 and a standard deviation of 15. VAS-R standard scores are normally distributed and can easily be transformed into a variety of other metrics including z-scores, normal curve equivalents (NCEs), and stanines using Appendix H of the Professional Manual (Gerhardstein Nader, 2013).

On 5/15/2013, Jane Smith was administered the VAS-R A. She was 10.4 years at the time of testing. Age norms were used to score this administration.

On testing with the VAS-R, Jane earned a standard score of 150. The chances are 90 out of 100 that Jane's true VAS-R score falls within the range of 144 to 156. Her percentile of 99.9 indicates that Jane performed better than 99.9 percent of other examinees of the same age. This places Jane's receptive vocabulary functioning in the very superior range.
